6. Since many communities have not responded for many years, there is a need to seek out ways to reach these communities to see if they would like to remain members. There are also many third order regular communities who may never have heard of IFC-TOR and may appreciate sharing the resources of the conference. Therefore, we would also like to **set up a recruitment committee to find new ways to reach out to these congregations for active participation in the conference.**

In order for us to move forward on the above- mentioned areas, we need people to work on committees to plan and formulate the programs. Please name a sister/brother or brothers/sisters from your congregation who would be willing to help by being on a committee. The committee members need not present the material but will make suggestions and contact people who could present the material for the resources.
