VII. Fraternal Life

23. **B**ecause God loves us, the brothers and sisters should love each other, for the Lord says, This is my precept, that you love one another as I have loved you (Jn 15:12). Let them manifest their love for each other in deeds (ER 11:5-6; TestCl 18). With confidence let them make known their needs to one another so that each can find and offer to the other that which is necessary (ER 9:10). Blessed are those who love the others when they are sick and unable to serve, as much as when they are healthy and of service to them. Whether in sickness or in health, they should only want what God wishes for them (Adm 24). For all that happens to them let them give thanks to our Creator (ER 10:3).

24. If discord caused by word or deed should occur among them, they should immediately (Mt 5:24) and humbly ask forgiveness of one another even before offering their gift of prayer before God (cf Mt 18:35). If anyone seriously neglected the form of life all professed, the minister, or others who may know of it, are to admonish that person. Those giving the admonition should neither embarrass nor speak evil of the other, but show great mercy (LtMin 15). Let all be carefully attentive not to become angry or disturbed because of another's sin. For anger and disturbance impede charity in themselves and in others (LR 7:3; FLCI 9:3-4).
